# WHAT MEDICAL BENEFITS AM I ENTITLED TO UNDER SOUTH CAROLINA WORKERS' COMPENSATION?

Suffering a work-related injury is not only physically and emotionally challenging, but financially difficult as well. One of the most pressing concerns in any workers' compensation claim is what medical benefits are available. The following is a brief outline of those benefits, and how they apply in a workers' compensation claim in South Carolina.



#### Comprehensive Medical Coverage

Under South Carolina law, injured workers are entitled to receive all necessary medical treatment that is likely to lessen their disability. This is to be provided without co-pays or deductibles. Such benefits include but are not limited to doctor visits, hospital care, surgery, physical therapy, prescription medications, medical devices such as crutches or wheelchairs, and even transportation, when medically necessary. Along with these benefits, an injured worker may also be entitled to mileage reimbursement for travel to and from medical and pharmacy visits when the travel exceeds 5 miles one way or 10 miles round trip.

#### **Selection of Treating Physician**

In South Carolina, the employer or its insurance carrier usually has the right to select the treating physician for treatment resulting from the work injury. Conversely, if an injured worker seeks treatment from a physician without prior authorization from their employer or the workers' compensation insurance carrier, they may be personally responsible for those medical bills. However, if an employer refuses to provide medical treatment, an injured worker may petition the Workers' Compensation Commission for an order requiring the employer to provide medical care. Additionally, in emergency situations, an injured worker may seek immediate medical attention at the nearest emergency facility.

#### **Duration of Medical Benefits**

Medical benefits may continue for as long as necessary to treat the work-related injury. For the most extreme and severe injuries, this may mean ongoing care for many years after the initial injury. There is no specified time limitation on medical treatment under South Carolina workers' compensation law. However, the treatment must be authorized by the workers' compensation carrier and related to the workplace injury.

#### **Second Opinions & Specialized Care**

If an injured worker disagrees with the recommended treatment or diagnosis, they may request a second opinion from another physician. While the insurance carrier is not obligated to grant this request, the Workers' Compensation Commission may order that a second opinion be provided under certain circumstances.

#### Conclusion

Understanding your rights to medical benefits under South Carolina workers' compensation law is essential to ensuring you receive proper care following a workplace injury.
